XOur Graduate School Partnership Program

(1) Partner graduate schools

These national, private, and public university graduate schools work together to use their mutual educational and research resources effectively and to enhance their capabilities to contribute to education, research, and society through links and cooperation among institutions of higher education. The partner graduate schools organize joint scholastic curricula and confer degrees in partnership.

(2) Special features of graduate school partnership

- 1. Degrees are conferred through collaboration between the University of Kochi, the University of Hyogo, Chiba University, TMDU, and the Japanese Red Cross College of Nursing.
- 2. A five-year integrated doctoral program is offered that is based on the Program for Leading Graduate Schools.
- 3. While students are registered with the five universities, they are actually enrolled in the university that the full-time faculty member who is primarily responsible for the supervision of their research (main faculty advisors) belongs to. Students are able to receive the same services as the other students at the university that they are enrolled at. Further, they can also use the libraries at universities where they are not enrolled. However, they may not be able to use some facilities, depending on the situations at the respective universities.
- 4. Students can receive research guidance from faculty members (auxiliary faculty advisors) at member universities other than the ones at which they are enrolled.
- 5. At the universities where they are enrolled, students can use audiovisual devices to attend teleseminars of lectures held by member universities.

% Important Announcement about Cooperative Doctoral Course in Disaster Nursing

- (1) Communication with the university to which you have applied (essential)
 - Regarding applications (including requests for approval of application qualifications), please contact the university to which you want to apply in advance and be sure to confirm the content of your research and the date of the entrance examination.
- (2) Regarding the university where you will apply, take the entrance exam, and be enrolled

Please submit your application to the university of your choice. You will take your entrance examination at that university.

You will be enrolled at the university where you applied and took the entrance examination, and you will be treated as a student of that university with regard to tuition payments, scholarship applications, and such.

(3) Point to note regarding submission of applications

The curriculum in this program is offered jointly by five universities, so anyone who has completed enrollment procedures for the cooperative disaster nursing program at one of the five member universities may not undertake procedures to enroll for the same course at the other member universities.




Tokyo Medical and Dental University Map
