【Tokyo Medical and Dental University (TMDU) and Tokyo Institute of Technology (Tokyo Tech) will be integrated to become "Institute of Science Tokyo" as of October 1, 2024.

Please note that those who pass the selection processes will be among the first students of the new university.】

Tokyo Medical and Dental University Graduate School recruits overseas students by own expense who will study oral health sciences as part of the International Priority Graduate Programs (PGP) as follows:

**1. FEATURES OF THE GRADUATE COURSE FOR INTERNATIONAL STUDENTS**

- (1) Students will engage study and research through the medium of English.
- (2) Students have the opportunity to take the following courses:
  - [Elective Basic Courses]
    - 1.Clinical Dental Training Course
    - 2.Dental Alliance Training Course
    - 3.Community Dental Health Training Course
    - 4.Dental Education Training Course
  - [Applied Elective Courses]
    - 1.Global Clinical Expert Course
    2. Global Dental Data Sciences Course
- (3) Students are eligible to submit a dissertation based on their research work to the Tokyo Medical and Dental University Graduate School. If the Tokyo Medical and Dental University Graduate School accepts such a dissertation as sufficient for a doctor's degree, the student will be awarded a Ph.D.

**5. QUALIFICATIONS**

- (1) Academic Background: either ① or ②
  - ① Applicants have completed an 18-year course of scholastic education (that ended with a curriculum that covered medicine, dentistry, pharmaceutical sciences, or veterinary sciences) in a foreign country or expects to complete such a course by September 2023
  - ② Applicants have received or expects to receive an academic degree equal to a bachelor's degree in foreign university or other institute by completing courses that are 5 years or more in length (that ended with a curriculum that covered medicine, dentistry, pharmaceutical science, or veterinary science studies) by September 2024
- (2) Language Ability: Applicants must have sufficient knowledge and skills in English.
- (3) Arrival in Japan: Applicants must arrive in Japan from September 15<sup>th</sup> through October 11<sup>th</sup>,2024.  
(\*1) Military personnel and military civilian employees registered on the active list are not eligible.

(\*2) Admission will be cancelled if an applicant fails to arrive in Japan by the designated date.

(\*3) Applicants who are expected to complete their 18-year educational course by September 2024 will lose their eligibility if they would fail to accomplish their undergraduate-level program by the period mentioned above.

## 6. APPLICATION SCHEDULE AND APPLICATION PROCEDURES

### 1) Application Period

Online Application Registration Period	March 25, 2024, 10:00 a.m. – April 4, 2024, 3:00 p.m.
Documents Submission Period	April 1, 2024 – April 5, 2024, 5:00 p.m.

Send the application by registered express mail or courier so that it arrives before the application deadline. Application documents submitted via email will NOT be accepted. Please note that it may take a long time for the package to arrive at TMDU depending on from where it is mailed.

### 2) Interview with Prospective Supervisor

Applicants are required to contact a prospective supervisor at TMDU to discuss on their research and education plans and get permission for your application before applying for this course.

You will be required to enter the date when you get permission for the application from your prospective supervisor. Please get their permission via e-mail and keep the e-mail until the entrance examination finishes. If any doubt arises in your application, you may be required to submit the e-mail.

\* In case it is found that you have not gained permission for application from the prospective supervisor, your application may be revoked.

### 5) Confirmation for Application Completion and Examination Admission Slip

Confirmation for Application Completion and Examination Admission Slip

① Confirm that your application documents have been received on the “Online Application Website.”

② Download the “Examination Admission Slip” on the “Online Application Website” and print it out. Confirm that the examinee’s number is printed on the examination admission slip.

## NOTES

1. The examination admission slip can be downloaded after May 13, 2024.

When the examination admission slip is ready, the notification will be sent via e-mail.

2. Print out the examination admission slip and have it on hand on the day of the examination.
3. Keep the examination admission slip because it could be needed for the enrollment procedures etc..
4. When there is an emergency announcement related to the Online Application Website, it will be posted on the TMDU website.

6) Application Documents

Please submit the following documents on the Online Application Website. Please submit the printout of the Form 1 and the original copies of the application documents marked (\*1) referring to “(2) Application Procedures③” and “(3) Mailing address.” Also, please upload the A4 sized colored scanned data of the documents marked (\*2) as PDF files on the Online Application Website.

The copies of the documents marked (\*1) will NOT be accepted. After application registered, the original can be returned to the applicant if necessary. Please put a note to let us know that they should be returned. They will be sent to the address registered at the time of application.

(1) Application Form (Form 1)

Print out the Application form after the application registration and send it by post.

This can be downloaded after entering the personal information on the Online Application Website

(2) Photo ID file

- A photo of your upper body with nothing covering your head taken within three months of the application

- Within 10 MB

(3) Field of Study and Research Plan (Prescribed form by the university: Form 2)

\*Upload the file as a PDF file.

(4) Study plan to be prepared by the applicant’s prospective supervisor at TMDU

(Prescribed form by the university: Form 3)

- Applicants need to contact and discuss your study plan with the prospective supervisor at TMDU and ask him or her to submit Form 3

- Ask the prospective supervisor to send the colored scanned data of Form 3 via e-mail and upload it to the Online Application Website.

- Ask the prospective supervisor to submit the original copy of Form 3 to the Graduate School Admission Team.

(5) International Application Form for graduate school admission

(Prescribed form by the university: Form 10)

\*Upload the file as a PDF file.

(6) Transcript and Certificate of (expected) graduation from all universities attended

(7) Transcript and Course completion (or expected completion) certificates of graduate school Master’s or Doctoral program (\*1)(\*2)

(8) Thesis by which the applicant earned his/her master's degree or its equivalent (in English)(if any)

\*Upload the file as a PDF file.

(9) Recommendation Letter(s): (\*1)(\*2)

Required: A letter of reference from a department chair of the institution to which the applicant belongs.

Desired: A letter of reference from a supervisor who knows the applicant personally.

**All recommendation letters should be addressed to “the President of Tokyo Medical and Dental University”.**

(10) A photocopy of your passport (\*2)

- (11) Entrance exam Fee: 36,000 JPY  
 \* There is handling charge for each payment of the examination fee.
- (12) Certificate of proficiency in the English language. (ex: TOEFL, IELTS) (\*1)(\*2)
- (13) Other official documents (if any)  
 Certifying your qualification, license
- (14) Documentary proof of surname change (\*1)(\*2)  
 (only if submitted ID documents differ from current surname)  
 Copies of both sides of driver's license, residence records, family register, passport or other form of ID  
 \* Residence records and family register are applicable to \*1.  
 \*Make sure that we can confirm the changes of your name.
- (15) Other documents TMDU deems necessary  
 (Documentation other than the preceding may be requested)

- Application documents and Entrance exam Fee, once submitted, will not be returned for any reason.
- All documents should be typed in Japanese or English on paper of the same size (A4 size, preferably), and be printed single-sided.
- An English translation is needed if an official certificate is in another language.

#### 8. SELECTION METHODS:

Acceptance to the Graduate School is determined solely by a review of the application documents submitted.

(2) Tuition and Other Costs (As of FY 2023)

Admission fee: 282,000 JPY

Tuition: 267,900 JPY (six months)

535,800 JPY (one year)

- If the admission or tuition fees are revised, the new amount will apply from the time of revision.
- Regarding the method of admission fee payment, details will be provided during enrollment procedures.

- Enrollment fees will not be returned for any reason.

- Payment of tuition after admission is done by automatic withdrawal from your bank account. (Details will be provided in the admission procedure.)

#### 11. OTHERS:

- (1) Changes to the contents of an application (including the change of the department you want to enter) are not allowed after the application package has been submitted.
- (2) If the name shown on a certificate in your application package differs from that shown on your application form, be sure to attach proof of your change of name.
- (3) Office hours: 9:00- 12:00; 13:00- 17:00, Monday–Friday
- (4) If any difference is found between facts and matters as described in your application documents, your enrollment may be canceled.
- (5) Handling of personal information.
  1. Personal information is collected in the application process and selection process, and may be used to carry out health guidance or education after admission. It will not be used for any other the purposes.
  2. Regarding personal information collected in the process of selecting entrants, the “National University Corporation Tokyo Medical and Dental University Personal Information Management Rules” will be followed and TMDU will not disclose any such information to third parties without consent of the applicant.
- (6) Applicants who are expected to complete their 18-year educational course by September 2024 will lose their eligibility if they would fail to accomplish their undergraduate-level program by the period mentioned above.
- (7) Students are encouraged to apply for scholarships other than the Japanese Government (Monbukagakusho) Scholarship.
- (8) Tuition may be exempted based on student's academic performance and financial status.
- (9) Students are advised to acquire some knowledge of Japanese culture, customs, weather, and the university system before coming to Japan. The use of English is given priority in study and research; however, some ability to speak Japanese will be needed right away to conduct your daily affairs in Japan. It is strongly advised, therefore, that international students acquire some level of Japanese language proficiency before starting at the university.
